District Residents are those who reside or own property within the physical boundaries of the cemetery district or have an immediate family member already buried in the cemetery.

No plot may be resold to anyone without the prior written consent of the Board of Directors. If it agreed that the plot may be resold, the prospective owner must first meet all of the cemetery burial criteria.

Two sets of ashes may be placed in niche compartment. They must be placed at the same time. The outside dimensions of urns or boxes shall be no greater than a 9" cylinder or 9" from corner to corner, with a height of 15".

One additional plaque per compartment made of the same material and size is allowed with Board approval. Additional plaques will be ordered by and placed by the Board.

SERVICES:

Full Casket Burial Service	\$125.00 (Opening & closing not included – contracted out.)
Cremation Service	\$100.00
Placement of Veterans Headstone	\$100.00

<u>Note</u>: Payment in full, including Endowment fees on all plots bought pre-1985, and the Application and Permit for Disposition of Human Remains must be presented to the District Chairman before burials are completed.

BURIAL, HEADSTONES & MAINTENANCE:

One casket per plot OR one casket and three interments per plot OR three interments per plot. Up to two interments per niche, to be placed at the same time. Burials will not be performed on Sundays or holidays.

Only flat headstones which are flush to the ground are allowed in any area of the cemetery. All persons occupying plot must have a marker or be listed on a marker.

The Cemetery District will assist family members with the placement of headstones furnished only by the Veterans Administration. All other headstones must be set by a company such as North County Memorials or Oregon Granite.

No glass containers are allowed in the cemetery.

Fresh flowers will be picked up as they wilt or dry up.

Artificial flowers will be discarded as they deteriorate.

Prior to Memorial Day all spent flower arrangements will be removed and discarded.
